

17. Summary of Mitigation and Residual Effects for the Proposed Development

- 17.1.1.1 **Table 17.1** sets out a summary of mitigation and enhancement measures that the Applicant has committed to implementing prior to and during the construction, operation and decommissioning phases of the Proposed Development to reduce significant residual effects. **Table 17.1** does not include 'embedded' mitigation which has been built into the Proposed Development during the design process, this is described in **Chapter 2 Site Selection and Design Evolution** and **Chapter 3 Description of the Proposed Development**.
- 17.1.1.2 Many of the mitigation measures noted in **Table 17.1** will be implemented through a CEMP. It has been assumed that the CEMP would be agreed with EAC prior to construction and a requirement for this would therefore be conditioned in the planning permission. The CEMP would be produced by the Applicant once planning permission has been secured and once agreed, it is the Applicant who would retain ultimate responsibility for ensuring that the Contractors comply with the CEMP and construction related planning conditions attached to the permission.
- 17.1.1.3 The significance of residual effects following the implementation of mitigation measures is also noted within **Table 17.1**. The definition of significance, particularly in respect of how this relates to "significant effects" in terms of the EIA Regulations, is described within **Chapter 4 Approach to Preparing the EIA Report**. A definition of how significant effects are derived for each topic is set out in the corresponding technical chapter along with the relevant explanation and descriptions of receptor sensitivity, the magnitude of change, and levels of effect that are considered significant in terms of the EIA Regulations.
