Once a company has registered, their details can be easily edited and updated as required in future, and will be fully listed within the search function.

RWE has created this searchable database to help make it easier for its own and other industry contractors to access registered businesses in Scotland, and to maximize opportunities emerging from the growing renewables sector. It is developing the largest offshore wind pipeline in the UK, and expects to grow its Scottish renewables base as part of a broader commitment to investing £15billion in the UK up to 2030. Further, a recent [RWE-funded report](#) with ORE catapult has flagged that the manufacture of low carbon concrete foundations for new floating wind projects from Crown Estate Scotland's ScotWind leasing round, also presents a major opportunity for local ports and businesses.
